## FEDERATION PRESIDENT



I want to express my thanks to all of you for giving me the privilege to continue as VFC President for a second term, 2011-2012. To date, it has been a very enjoyable experience primarily due to our strong and capable Federation Board as well as the hospitality, extended to me by all of our Chapters. I sincerely hope that all of us together can continue to promote the objectives of the Virginia Federation. I fully believe that we can accomplish a great deal because you are members you care about the NARFE organization.

MEETINGS - - MEETINGS - - MEETINGS - - While many chapters take the summer off from their activities, the members of the VFC Executive Board continue with the business of NARFE. While the "Protect America's Heartbeat" campaign continues to occupy our time, we also have been involved in meetings on the Federation, Regional and National levels. In July, the VFC Board met in Richmond and addressed a full agenda of business. A short summary

of the VFC Executive Board actions is provided by the VFC Secretary and other details of much of the material discussed will be set out in the articles of the Area Vice Presidents and Committee Chairs later in this issue. Additionally, the approved VFC Budget for 2011-2012 is provided by the VFC Treasurer.

Following the VFC Executive Board meeting, I attended the combined National Executive Board (NEB) / Federation Presidents' (FP) meeting which was held in Sparks, Nevada. This meeting is held every two years at the site of the upcoming NARFE National Convention which allows the Presidents to see first-hand the facilities we will be using for our the 2012 Convention. There was a lot of information that was provided or exchanged at this meeting, including reports from National Information Technology Advisory, By-Laws Review and Recruitment/Retention Committees. The presenters did a great job and the Q&A sessions helped the committees in redefining the individual reports. While all of the committee should be commended for their efforts, the one that I found most informative was the presentation of the National Information Technology Advisory Committee (NIAC). The NIAC was charged with auditing the information technology structure at NARFE Headquarters (HQ) with specific attention directed to simplifying the on-line reports which are accessibility from the main NARFE website. Over the years we have all heard promises from NARFE HQ that our needs and concerns about the accuracy and usability of the reports, but hopefully, by the time you are reading this message, the new formats of the on-line reports will be available to all users. If not, please be assured that **CHANGE IS COMING SOON!!!!**

Additionally, there were three presentations, made by Iowa FP Larry Moore (Membership Recruitment), Ohio FP Ed Konys (Public Relations/National Advertising Program) and Washington State FP Sandra Cagle (Chapter/Federation Leadership). These presentations were as outstanding as the committee reports and the exchange of additional information that occurred between the FP's and the NEB should be very beneficial to the future of NARFE. As more information becomes available, I will bring it to the VFC Executive Board for review and consideration for implementation within the VFC.

A major highlight of the meeting was the interaction of the other persons who are also serving as Federation Presidents. In particular was my meeting with Texas Federation President Marshall Richards. President Richards is a very enthusiastic individual and is anxious to excel during his tenure as Texas President. Prior to the FP meeting, it was brought to my attention that during the 2011 Texas Federation Convention, he stated to Jane Beaudoin (Winchester - Chapter 180) that he wanted to issue a challenge to the Virginia Federation of Chapters with regards to Alzheimer's Research donations. On behalf of the Virginia Federation of Chapters, I accepted the challenge of the Texas Federation. For full details on this challenge, be sure to read the article prepared by VFC Alzheimer's Chairman Donna Shackelford in this issue.

In August, I attended the Region X Presidents' Conference which was held at the Cumberland Falls State Resort Park in Corbin, Kentucky. Also in attendance from Virginia were 1st Vice President Luther Santiful, 2nd Vice President Richard "Dick" Giangerelli, Area IX Vice President Pierce Johnson, Area X Vice President Kathy Arpa, Public Relations Chairman Gaston Gianni, Co-Service Officers Constance and John Bails and Alzheimer's Chairman Donna Shackelford. This conference is held every two years by the Region X Vice President and the purpose is to bring the Federation leadership from Kentucky, North Carolina, Tennessee, Virginia and West Virginia together for the purpose of examining problems/concerns within each Federation and brain-storming possible solutions to these issues. The theme of this conference was "Leadership and Marketing" with an emphasis on 1) Service Officers and Their Influence in NARFE; 2)

Marketing Issues; and 3) Leadership Issues. Information gained from the NEB/FP Conference and the Region X Presidents' Conference will be used by the VFC Executive Board to develop training sessions to be held in the early part of 2012.

The process of developing a VFC Strategic Plan to help us set and achieve our goals for future years is moving forward. As with development of any long-range plan within an organization, there is never a consensus on the most important issues facing the members. Input was solicited from all members of the VFC Executive Board, Committee Chairs and Area Vice Presidents. There were a total of 74 items that had been identified in the following 8 major categories: (1) Administration/ Operations; (2) Communications; (3) Training; (4) Information Technology; (5) Membership; (6) Service; (7) Legislation; and (8) Public Relations. Three other areas of interest/concern were added by the individuals providing the input. Interestingly each of these new areas were major topics of discussion among the attendees at the NEB/FP meeting in July. Each of these three areas were in the areas of membership recruitment, public relations/national advertising program chapter/federation leadership. Additionally, an area of the VFC Strategic Plan survey concerned the area of Information Technology and it was expressed by the respondents that NARFE HQ should take lead in these matters which was a major portion of the presentation of the NIAC. Using the information gained from the survey, I will work with Pierce Johnson, Area IX Vice President, and Gaston Gianni, Public Relations Chair to further consolidate the input and discuss with the VFC Board which important goals should be placed in the Strategic Plan. **REMEMBER** - - that in Virginia, there are 108,000 annuitants, 31,000 survivor annuitants, 144,000 active federal employees and 15,000 postal employees. Currently, there are about 20,000 members in the VFC. The overall goal of the Strategic Plan will be to attract more members as well as retaining our current members. Our strategic plan will have a Purpose, Mission, and Vision Sections before describing our strategic goals.

#### **FEDERATION 1st VICE PRESIDENT**



The final results of the 2011 VFC Convention are now in. All measurement sources confirm attendee satisfaction and a positive financial outcome. As overall convention coordinator, I want to express my appreciation to the convention committee, under the able leadership of Leslie Ravenell, Area VIII Area Vice President, for the outstanding display of teamwork that produced a convention to be remembered. Plans are already underway for the 2012 convention. Please feel free to forward any ideas you have that you think will help make the 2012 convention equal to or better than the 2011 one.

In July of 2010, all AVPs agreed to encourage chapters to recruit an average of at least one member per month. As a result of their efforts during the period of 1 July 2010 to 30 June 2011, eleven chapters averaged one or more members per month. Winchester Chapter 180 led all chapters by recruiting an average of three members per month. Unfortunately, 14 chapters did not recruit any members during the entire year. The composite results for the VFC show an average of 28 recruits per month for the 58 chapters included in the assessment. I believe with a little more effort all chapters can average at least one new recruit per month.

The VFC Board approved funding for officer and committee chair training at four locations around the state during the spring of 2012. In the meantime, AVPs have been asked to request committee chairs to conduct whatever training chapters feel they need at Area meetings. All VFC committee chairs have training modules prepared and will conduct them upon request. Areas VI and VII included well-executed training in their recent Area meetings.

Recent months have included a flurry of activity regarding protecting our earned benefits. I have visited congressional offices, called repeatedly, written some letters and visited chapter meetings with members of congress in attendance. I have been pleased with the activities of some chapters and members who have taken this campaign seriously. We have gotten the attention of some members but we have lots more to reach and educate. It is unrealistic to expect a member of congress to support our issues if he or she does not know what they are. Therefore, it is up to NARFE members to meet with members of congress and explain our issues. This is critical for new members who may not otherwise ever have any interest in the plight of federal employees.

I encourage all members to review the R. David Smith Memorial Award criteria posted on the VANARFE website ([www.vanarfe.org](http://www.vanarfe.org)) and aspire to be a nominee or nominate some other member. George Hawkins of the New River Valley Chapter was the most recent winner. Recruit a member!

#### **FEDERATION 2nd VICE PRESIDENT**



The primary role of the VFC 2nd Vice President is to be ready to assume the responsibilities of the VFC President and the VFC 1st Vice President in their absence, to be the primary contact person for the VFC Chairs, and to assure that the VFC Chairs are carrying out their assigned duties. Since being elected in April 2011, my job has been a fairly easy one, as we have a strong and active VFC President and VFC 1st Vice President, and a very competent group in the VFC Chair positions.

I ask that you give your support to the following recent appointees to some of these positions:

- Eugene Brown - VFC State Legislative Chair
- Gaston Gianni - Public Relations Chair,
- Maureen Nolet - Nominating Committee Chair, and
- Joe Gresko - State Legislative Representative.

I also want to thank Jim Brewer for continuing to fill the VFC National Legislative Chair position while we try to find a new person to fill that position. However, we do hope that Jim will consider continuing to hold the position of VFC National Legislative Chair.

I encourage you to read the reports in these VFC Notes from all of the VFC Chairs. You will find them quite interesting and informative. However, there are a few issues that I would like to emphasize.

We do have vacancies in the Congressional District Liaison (CDL) and Senate Legislative Liaison (SLL) positions that need to be filled. These are very important positions that cannot remain vacant. Jim Brewer will provide training on a person-to-person basis and is scheduling a training session in conjunction with the 2012 VFC Convention. We do not yet know where the new boundaries for the Virginia Congressional Districts will be, as this information will not be made available until the December 2011 timeframe; however the current positions still need to be filled.

Eugene Brown is working hard to finalize and print the 2012 VFC State Legislative Plan, and it should be available soon. The decision on which Virginia General Assembly candidates to give financial support to has been delayed until the October 2011 VFC Board meeting, so there is still time to make contributions to the VFC State PAC fund. This year, we have tried to make it easier to make State PAC contributions by allowing the use of credit cards; however, to date, only two members have utilized the credit card method.

Dennis Martin has set a goal of a 10% increase in membership this year. How well that goal is met will be reported at the 2012 VFC Convention, together with the announcement of the first place, second place, and third place winners of the current VFC membership contest. Unfortunately, as Dennis reports, it appears that this will be a difficult goal to meet, as the Virginia Federation had 208 (approximately 1%) decrease in NARFE membership in 2010 and between January 1, 2011, and July 1, 2011, had an additional 281 (approximately 1.5%) decrease in NARFE membership when not considering the new E-NARFE Chapter headquartered in Alexandria, Virginia. Between April 1, 2011, and July 17, 2011, the E-NARFE Chapter has grown in size from zero members to 988 members, 144 of which are residents of Virginia and the remainder of which reside in the other 49 States, the District of Columbia, Puerto Rico, and foreign countries. The strength of NARFE is based on the number of NARFE members, so we need you to emphasize recruitment and retention. If you wish to see what the possible size of the NARFE Virginia Federation could be, take a look at the website [www.eyeonwashington.com/few\\_map\\_2010/htm/Virginia.html](http://www.eyeonwashington.com/few_map_2010/htm/Virginia.html).

Connie and John Bails have been very active in visiting Virginia Federation Chapters and making the functions, responsibilities, and importance of Chapter Service Officers known. Currently, a training meeting for Chapter Service Officers is in the planning stage. They even organized and led a discussion of Federation Service Officer's functions and responsibilities at a NARFE Region X Presidents' Conference in Kentucky in early August 2011.

Donna Shackelford continues to do a great job as the VFC Alzheimer's Chair. Donna reports that the Virginia Federation is again the number one contributor to NARFE Alzheimer's Research. Her report has a lot of information and I suggest you make sure to read it.

Gaston Gianni has really grabbed hold of the functions and responsibilities of the VFC Public Relations Chair. He is in the process of re-invigorating the effort to make the NARFE Virginia license plate a reality, so expect to hear from him in the very near future. Gaston also organized and led a discussion on possible public relations activities at the Federation level at the NARFE Region X President's Conference in Kentucky in early August 2011. Again, I recommend that you pay close attention to Gaston's report.

Finally, I encourage you to consider contacting Maureen Nolet (telephone no. 540-370-0036, e-mail [nltmaureen@aol.com](mailto:nltmaureen@aol.com)) or your Area representative on the VFC Nominating Committee and volunteer to become a candidate for one of the five officer positions on the VFC Executive Board. To date, there is no nominee for the VFC 2nd Vice President's position for next year, and only one nominee for each of the other four VFC officer positions. A complete description of the functions and responsibilities of these positions is published in the VFC Organizational Handbook, which is available on the VFC website at [www.vanarfe.org](http://www.vanarfe.org). Elections will be held at the 2012 VFC Convention.

**Richard "Dick" Giangerelli – 2nd Vice President**

#### **FEDERATION SECRETARY**



In July, the VFC Executive Board met in Richmond and addressed a full agenda of business. Some of the actions taken at the meeting included the following:

- A goal to increase VFC NARFE membership by 10% during fiscal year 2012 was adopted.
- President Bill Shackelford directed PR chair Gaston Gianni to assume responsibility for the continuation of the VFC License Plate project.
- Due to a growing number of vacancies in the CDL / SLL positions, the nine-month goal to have 90% of the CDL / SLL positions filled could not be met. Since CDL's and SLL's must reside in the Congressional District that they represent and since new boundaries for the Congressional Districts will probably not be

finalized and approved before December 2011, some CDL's may need to be re-assigned. Funds have been budgeted to partially pay for CDL's and SLL's to attend the 2012 VFC Convention and to participate in a special meeting for training.

- VFC Biennial Training for FY 2012 will be led by 1st Vice President Luther Santiful. It is recommended that training be provided for Chapter Public Relations Chairs, Chapter Membership Chairs, Chapter Service Chairs, and Chapter officers. As in the past, training should be held in four areas around the State to encourage maximum participation. Possible locations include Manassas, Roanoke, Charlottesville, Williamsburg, and Richmond. A budget of \$7,000 has been allocated in fiscal year 2012 for this effort.
- The adopted criteria for the R. David Smith Award were amended by deleting the phrase "during the award period of January 1 – December 31." It was also proposed to change the lead-in sentence of the Selection Criteria to read: "One nominee will be selected by applying at least three of the following criteria for accomplishment during the previous calendar year." The last stated item under the selection criteria were revised to read "Recognized recruiter of NARFE members."

## **REGION X VICE PRESIDENT**



For this issue of the VFC Notes, I would like to emphasize the importance of Chapter Service Officers. At the recent Region X Conference, your Federation Co-Service Officers, Connie and John Bails, conducted a workshop on the importance and functions of Service Officers and the service which is provided to NARFE and its members. It was an excellent workshop and included four other Region X Federation Service Officers. As a result, we hope that the Service function begins to receive the recognition it deserves. Chapter and Federation Service Officers have four basic duties listed below. To review these duties and the entire function, please refer to NARFE F-58 (Revised-06/09).

1. **Meet the practical needs of chapter members.** The basic responsibilities include:
  - Helping individual chapter members, their families and survivors take the proper actions to obtain and retain their annuities and survivor, health, long-term care, and federal group life insurance benefits;
  - Providing support to members having serious problems with their benefit arrangements and particularly to surviving spouses when they suffer the trauma of a death or serious illness.
2. **Facilitate liaisons between members and OPM.** A major aspect of the function is to assist chapter members with problems involving programs managed by OPM and to facilitate communication between the two.
3. **Help expedite applications for benefits.** These include working with OPM on Death Benefits, Changes in Marital Status, and Federal and State income tax withholding issues.
4. **Help members obtain information about the Federal Employees Health Benefits Program (FEHBP) and Medicare.** This would also include Long Term Care.

Although the Service Officer can help with other agencies, such as Social Security, TRICARE for Life, Veterans Benefits, and Unemployment compensation the help will be just providing names and phone numbers. Their major contact will be with OPM.

If your chapter does not have a Service Officer, please consider volunteering for the position. If you do have a Service Officer, please thank that individual for taking on the job. It's a very important one and can result in great satisfaction.

I want to thank Connie and John Bails for a wonderful conference, and to thank your VFC President William "Bill" Shackelford for supporting them in their efforts. We all benefit from the work that Service Officers provide. Finally, my thanks also go to all Service Officers. You all are holding a very important function. Thanks!

## **ALZHEIMERS**



If you did not already know, the 2011 Convention for VFC yielded \$3,732 for Alzheimer's Research. All of our members should be very proud of the accomplishment. Our Region X Alzheimer's Chair was very impressed, and her report to Barb Pretzer (National Alzheimer's Chair) was indeed very complimentary to me and to all of you who make it all possible to raise money to combat this terrible disease. She noted that Region X is the top Region in the nation for donations, and of course, Virginia is the top Federation. Through the end of May, 2011, nation-wide NARFE has raised \$9,246,049.39, over the past 25 years. Your own Federation has contributed more than \$78,000 through the end of June 2011 for just one year and is responsible for more than

10% of the total donation for those same 25 years.

I was asked what the top chapter in the nation is for donations, and I made some further inquiries through the Region and National officials. I learned that Port St. Lucia Chapter 1589 in Florida has contributed over \$15,000 through the end of May, making them the leading single Chapter. Of course, Virginia has an outstanding Chapter also in Woodbridge 1270, and they will strive even harder than ever. Rumor has it they want to be No. 1 in the Nation!!!

**VFC has been challenged by Texas Federation:** I was also in attendance at the National Executive Board (NEB) / Federation Presidents' (FP) meeting in Sparks, Nevada. As previously stated by VFC President Bill Shackelford earlier in this issue, during the 2011 Texas Convention Federation President Marshall Richards stated to Jane Beaudoin (Winchester - Chapter 180) that he wanted to issue a challenge to the Virginia Federation of Chapters with regards to Alzheimer's Research

donations. This challenge was that the Texas Federation would be the first Federation to raise in excess of \$100,000 without the benefit of wills or corporate donations being given to the Federation. With just over 10,000 members in the Texas Federation, it is the intention of President Richards to request \$10.00 from each of his members, thereby reaching the \$100,000 goal. It should be noted that during the recently completed Alzheimer's Association fiscal year which ended on June 30, Texas raised just over \$14,000 for Alzheimer's Research while VFC members raised over \$78,000. On behalf of the Virginia Federation of Chapters, President Shackelford accepted the challenge of the Texas Federation. *Come on, Virginia, are we going to let Texas beat us out ???!!!*

Our organization has made it even easier now to donate. Members can now contribute by using a credit card. Please help to spread the word by explaining to your Chapters how this will work. Another choice is to go to my web page at [vanarfe.org](http://vanarfe.org) and follow the prompts there. I also want to mention that my web page has lots of information about Alzheimer's disease, and it changes every week. If you have any questions, please feel free to use it.

Many of you want to know what your money is producing. The latest I know is that a new drug, Namenda, leads all other therapies approved for Alzheimer's Disease by a wide margin for use in newly diagnosed patients. This drug was discovered at least in part as a result of funding from NARFE. It is approved for the treatment of moderate to severe Alzheimer's disease in the US and is often prescribed in combination with other treatments.

What if you were told you carried a gene that increases your risk for Alzheimer's? And what if you were told this gene starts to do its damage not when you're old but when you're young? Scientists know there is a strong genetic component to the development of late-onset Alzheimer's. In 1993 researchers discovered a gene known as ApoE4 -- carried by about a quarter of us -- that triples the risk for getting Alzheimer's. In 2009, three more risky genes were discovered and one of them, known as CLU, was found to increase the risk of getting the disease by another 16 percent. UCLA researchers now know the CLU Gene begins to damage your brain a full 50 years before people normally display the characteristics of Alzheimer's. If the gene can be identified while a person is young, the window to intercept its influence is much greater. The mapping of structural brain differences in those at genetic risk for Alzheimer's is crucial for evaluating treatment and prevention strategies.

Please remember that if I can help you in any way with your Chapter, I am very willing to do so. I've spoken to a few Chapters and I'm willing to come anywhere in the Commonwealth. We must get the word out and make the public aware of the disease and the efforts being put forth to eliminate it. We will probably be getting information soon about the achievements made in Paris at an international conference on Alzheimer's held in July. I'll share that information whenever I can.

#### **MEMBERSHIP**

The membership contest, started in August of 2010, continues to show good results with a total of 323 new members recruited by VFC members to date. I am encouraged by this high level of recruiting.

The VFC membership totals for the first half of the year have declined. If I may add, rather significantly. The total is down by 281 members which is worse than for this time last year when the losses were 171 members.

Transfers, in and out, are reversed from the norm. That is, this year there are more transfers in than out.

Reinstatements are ahead of last year; however, non-renewals are also ahead of last year resulting an overall loss in membership. Another disturbing fact is that second renewal notices were ahead of last year.

The addition of new dues withholding members has slowed significantly this year and is only up less than 1% for the first six months. This is an area that needs to be addressed.

And, on a final note, NARFE HQ has added a national e-NARFE chapter wherein all transactions will be over the internet. The chapter currently has 953 members. Considering the fact that it started in April, it's apparent that there is a lot of interest in this type of chapter.

**National Legislation Strategic Plan Update** - - - Since the last VFC Board meeting, I re-evaluated the 12 month step in the Strategic Plan to include two (2) main changes. Change one (1) included VFC support to allow VFC Congressional and Senatorial Liaisons to attend an annual meeting for the purpose of furthering our Legislative network, brainstorming to determine various methods to be more effective or efficient, and a report of respective Congressional districts, past and future, events at the VFC 2012 Convention during the National Legislative breakout session. During the National Legislative breakout session, we also hope to gain a better perspective of the needs or concerns of the members in the respective Congressional Districts. Change two (2) concerned enhanced VFC Area networking by including Congressional District Liaisons in Area Vice Presidents meetings with their Chapter Presidents. As of this date, the VFC President and Board of Directors acted on Change one (1) and has authorized increased support to allow a National Legislation yearly meeting. In addition, numerous Area Vice Presidents have included Liaisons in their respective area meetings in support of Change two (2). This is another giant step forward for NARFE VFC National Legislation. Together, we can make a difference.

Accordingly, during the next Strategic phase, we are in hopes of using the information gained between now and the April 2012 meeting, to achieve greater Legislative clout with our Congressmen and Senators. Thanks to all who have provided feedback and support.

NARFE National Call Day was July 27th, 2011. Accordingly, phone lines were jammed with participants calling in to ask Congress not to cut your earned benefits. Some callers that were unable to call in, used the fax numbers I provided and faxed in their comments. Others sent letters to their Congressmen with the same type requests and other information. In Virginia, NARFE members have logged over

13, 558 traceable email messages from over 2,262 VFC NARFE Activists, coming in second only to Florida, which logged the most messages sent in. In addition, NARFE VFC members made 189 phone calls to Congress and 58 calls to the White House, coming in second only to California. This doesn't include family, friends and non-member Federal employees that also supported the event. I recommend we step up even further and take the lead away from Florida and California.

On June 30, 2011, NARFE members were invited to attend a rally sponsored by the AFGE (American Federation of Government Employees) at Congressman Cantor's Richmond office. Again, Congressman Cantor failed to show his face to listen to the issues and concerns of Federal Employees, however, his staff members did collect our comments. Special Thanks to Richard Gingerelli, Jack McMurchy and Carol Graham who attended the event to represent our issues and concerns.

As we all know, there has not been a COLA in the last two (2) Years to Federal Pensions annuities, even though prices at the pump, store(s) and health insurance, medical co-pays has increased dramatically. The projected COLA reflects an approximately 3.5% increase to annuities for CSRS employees if cost's hold through the 3rd quarter. If costs increase, the CPI-W index will increase. For FERS employees, the COLA is currently projected to be 2.5%.

Letters to the editor are a great way to be heard. Several Letters recently have been reported in local newspapers and it's a great way to educate the public as well as Legislators. I recommend each Chapter start a "letter to the editor campaign". I also recommend you keep your Congressional District Liaison in the loop so we can all share successes with others.

Don't Forget Grass Roots Advocacy month currently scheduled for August 5 - September 7, 2011. The August Congressional recess provides the perfect opportunity to meet with members of Congress in their home districts. During these periods, NARFE's local presence can have a tremendous impact on advancing our legislative agenda. It is vital that Chapters and federations schedule meetings with their Representatives and Senators, as well as plan letter-writing campaigns. Chapters in each Congressional District are encouraged to plan outreach efforts with respective Congressional District Liaisons, Senatorial Legislative Liaisons, Area Vice Presidents, and Chapter Officers and members. Some Representatives or Senators may have been reluctant to schedule meetings due to the on-going budget-debt ceiling crisis discussions, there's now time to schedule these meetings. Don't be left out.

#### **PUBLIC RELATIONS**



Before getting to my report, I want to raise two questions that I think many people have about Public Relations. WHY ARE PUBLIC RELATIONS IMPORTANT? WHAT CAN WE DO AT THE CHAPTER LEVEL TO MAKE A DIFFERENCE? First you have to think about NARFE's principal mission, protect the earned benefits of Federal employees and retirees. That can only be done by having a large and strong membership organization. That means the more members NARFE has the stronger we can be on Capitol Hill with the legislators and in our States with our Congressional delegations. Large numbers have a greater chance of being heard! This means MEMBERSHIP RULES!!

Public Relations' mission is to raise the visibility of NARFE at all levels—Nation, State and Local. The public, especially active federal employees and retirees need to know who we are, what we stand for and what we accomplish in our communities. Making NARFE visible in your communities is a way of attracting new members. There are many activities at the chapter level that can help raise awareness of NAFRE. We just have to let others know about our efforts. Also, knowing where potential members work or live will help you better target your resources. As VFC PR Chair, I will be working in the coming months to develop information for use in targeting potential members at the chapter level. But each chapter needs to do research to identify government facilities, retirement centers, health fairs or other events that can be used as opportunities for recruiting new members. Remember that through Public Relations you make NARFE more visible.

**The VFC Public Relations Chair is open for business!** I'm asking Area VPs, Chapter Presidents and Chapter PR Representatives to let me know how the VFC can help you. Send me an email or give me a call—703-508-4339 and let me know what we can do to help. Remember matching funds are available to help you with recruiting projects costing \$100 or more. Guidelines will be posted on the Public Relations section of the VFC web site. Also the VFC has purchased some PR materials (bags, sticky note pads, letter openers, tape measurers) that can be used at recruiting events.

During the past few months I have been busy attending NARFE meetings. The quarterly VFC Board meeting minutes contain my quarterly report. So I won't repeat it here. I also made a presentation to the Board on the input received to date from Chapters, Area VPs and Board members on issues for consideration in developing our strategic plan. I attended the NARFE National Executive Board meeting in Reno, NV as a member of the National By Laws Review Committee. This was the first face to face meeting of the committee and we made good progress. We briefed the NEB on our progress to date. We still have more work before the Committee's suggested revised By Laws and Standing Rules are presented to the NEB in November. Afterwards, the committee's proposal will be made available to the NARFE membership for comment. The committee will then make any changes it deems necessary and the final package will be voted on by the membership at the National Convention in August 2012. I also attended the NARFE Region X Presidents' Conference to make a presentation on —How to Market NARFE□. My briefing will be posted on our web site. Finally, I participated in a Protect America's Heartbeat meeting on Capitol Hill with Senator Jim Webb's Chief Council. The purpose of the meeting was to present letters from our membership and to explain how our members have earned their benefits and that they should be protected. Contacting your congressional representatives is another way to advance NARFE's mission. Everyone can and should do it!

In the coming months, we will reintroduce our VA License Plate project. This could be an important step forward for the VFC in making the NARFE name more recognized. This will help build our membership totals in VA. We will be asking for your help and participation. Please don't let us down! I will also be working on getting more PR information on our VFC website. Your suggestions are

welcomed. Finally, several members have asked about advertising in your local areas. This is one way of building NARFE awareness. One of the keys to an effective ad is making sure that it is placed where the most potential active or retired federal employees can see it. This requires some research before ad placement. As stated above, we need to know where the active employees work and where retirees live. Let's work together in the coming months to build NARFE's image and to attract new members and to retain our current members. I wish each Chapter much success with their PR efforts in the coming months.

### SERVICE OFFICERS

**Heat Safety Basics** - - To keep cool as the summertime heat continues follow this general advice:



- Drink plenty of fluids: **Drink two to four glasses** of cool fluids each hour. Your body needs water to keep cool. Drink water even if you don't feel thirsty.
- **Do not drink caffeinated or alcoholic beverages** because they dehydrate the body.
- Keep cool indoors: If you can, **stay in an air-conditioned area**. Resting for just two hours in air conditioning can significantly reduce heat-related illnesses. Consider spending the warmest part of the day in public buildings such as libraries, schools, movie theaters, shopping malls and other

community facilities.

- Electric fans may provide comfort, but with temperatures in the 90s, fans will not prevent heat-related illness. Taking a cool shower or bath, or moving to an air-conditioned place is a much better way to cool off.
- Plan outdoor activities around the heat: If you must go outside, **go before noon or at night** when it's cooler.
- Avoid strenuous physical activities or reschedule them for the coolest part of the day, usually the early morning. **Limit physical activity** until your body adjusts to the heat.
- **Eat light meals**, avoiding high-protein foods because they increase metabolic heat.
- **Don't take salt tablets** unless directed by a physician.
- Wear light-colored clothing, which helps reflect sunlight.
- **Wear sunscreen** to prevent sunburn. Sunburn makes it more difficult for your body to cool off.
- Never leave children or pets unattended in a car—not even for a few minutes.
- Ensure your home's cooling system is working properly before it is truly needed.
- Make sure your home is well insulated and that you have weather stripping around your doors and window sills to keep the cool air inside.

Residents may visit county facilities such as senior centers, RECenters, community centers and libraries for temporary respite from the heat, however, residents should call the facility first to verify hours of operation.

**Heat-Related Illness and Heat Stroke** - - Be alert for the signs of heat-related illnesses like heat stroke. It occurs when the body is unable to control its temperature: the body's temperature rises rapidly, loses its ability to sweat and is unable to cool down. There are several warning signs people should look for during prolonged, extreme heat exposure:

- Extremely high body temperature (above 103 degrees)
- Red, hot, dry skin (no sweating)
- Rapid, strong pulse
- Dizziness, nausea, paleness
- Throbbing headache
- Shallow, fast breathing

If these symptoms are present, call for immediate medical assistance because heat stroke can cause death or permanent disability if emergency treatment is not provided quickly. While medics are en route, caretakers should get the symptomatic person to a cool, shady area.

Cooling the person with a hose, cool shower or tub bath is important. Monitoring the person's temperature and continuing cooling efforts are critical.

From 1979 to 1999, excessive heat exposure caused 8,015 deaths in the United States, according to the federal Centers for Disease Control and Prevention. During this period, more people in this country died from extreme heat than from hurricanes, lightning, tornadoes, floods and earthquakes combined.

**STATE LEGISLATION**



This is my first report since being appointed as the new State Legislation Chair. I attended a State Legislation Committee meeting on June 16 at which time we prepared a draft plan for the 2012 Legislative Session. The plan consisted of issues of concern to members of the VFC that could be addressed by legislation along with a list of candidates who supported NARFE and VFC issues, and who would possibly need political contributions for election. Shortly after this meeting I was appointed as the State Legislation Chair. I presented the 2012 legislative plan at the July Board Meeting held in Richmond. The plan was accepted, with amendments. It was recommended that the issues in the plan be organized to fit on an updated tri-fold brochure, and be presented at the October 2011 VFC Board meeting. The final plan will then be distributed to members of the General Assembly, Virginia NARFE members, and other interested parties. It was also determined that we would wait until after the August 23 primary to determine which candidates would be listed on the ballot. A committee of four, the two legislative representatives, Jim Bradley and Joe Gresko, and Richard Giangerelli, and I will report at the October 2011 VFC Board meeting on those candidates who have viable challengers for office and meet the criteria to receive our financial support.

A major concern continues to be the level of donations to the VFC State Political Account. We need to increase our donations so that candidates for the General Assembly will seek our endorsement. I welcome any ideas that you have to improve our giving to the VFC Political Fund.

It is also very important that we contact our State Legislators on specific issues and bills. I will work with Jim Bradley and Joe Gresko to keep you informed about the activities in the General Assembly.

We need to make a significant effort to increase the funds in the VFC PAC as there will be 140 seats open for candidate support this fall. Each Chapter is encouraged to make an effort to find donors for the VFC Political Fund. The coupon for making donations is below and also in the State Legislation section of the VANARFE web site.

Sam Harris (Tuckahoe ) was elected as the VFC Treasurer. After the convention, Bob Boyd (Midlothian) (former Area VP) was appointed to a 3-year term by the VFC President on the Constitution and Bylaws Committee. Carroll Graham, Tuckahoe, retired □ as the Senior State Legislative Representative after the June 16th. Meeting.; and Jim Bradley (Midlothian) was appointed to replace him. I thank both Barbara and Carroll for their service and welcome, Marv, Joyce, Bob, Sam, and Jim to their new VFC jobs. Also, I would like to thank all 6 area coordinators for returning . They are Winn Hasty (Petersburg) – National Legislation, Carroll Graham (Tuckahoe) – State Legislation, Marv Hecker (Midlothian) – Alzheimer's, Bettye Thornton (Imperial Plaza) – Membership, Larry Garelick (Richmond) –Public Relations/Newsletter Editor; and Jim Bradley (Midlothian) Service Officer.

I presided at our first Council of Chapters meeting since the convention on June 10th. We had 9 presidents/coordinators, and VFC 2nd Vice President Richard Giangerelli attending. The emphasis of the meeting was on the "Protect America's Heartbeat" campaign and preparing for NARFE Advocacy Month.

Two area newsletters were published in April-May and June-July on the VFC website. The June-July newsletter included convention news and activities chapters have taken during the America's Heartbeat campaign. Also a template and addresses for writing senators/congressmen were provided for members without computers to copy and send.

Membership numbers fell for all chapters for the first time during June. The number of new members has remained the same as in the past, but renewals are lagging even though retention efforts continue. Membership/retention officers reported some members not renewing said it was because of the national dues increase or else the lower amount charged E-Chapter members.. Also, in several chapters (especially Petersburg and Imperial Plaza) more members are dying than in the past. Among the leaders we lost were Pat Hoffert (former Midlothian president) and Carey Brown (Petersburg's top recruiter). Midlothian and South of the James recruited again at the May Chesterfield TRIAD meeting. Petersburg is continuing Lunch and Learn meetings every other month in the Ft. Lee EEO Conference room. Meetings were held in May and July. Attendance is slowly increasing. Hopefully we will begin getting new members.

This was a busy time for chapter visitations. I visited five of the chapters twice and spoke about America's Heartbeat, and urged members to become active. Midlothian, Petersburg, Tuckahoe, and Colonial Heights seem to be the most active, but there is concern about our entitlements in all chapters.

Before the convention, I participated in the telephone conference with 3 other Area Vice Presidents, VFC officers, HQ personnel, Florida members, and Will Hartman, M&R. Then we urged delegates to the convention to write letters which were collected by Senator Warner's staff members at the convention. Webb's Richmond office on April 25th. Both Ms. Osborne and I had reader's letters published in the Richmond Times Dispatch in May. There was good area member participation in telephoning senators, congressmen and the White House and writing many additional letters. On June 30th. I spoke briefly at a rally at Congressman Cantor's Glen Allen office. Most of the participants were AFGE members. Carroll Graham, Richard Giangerelli, and I represented NARFE.

### **AREA IV**

Currently, our Area has three Legislative Liaison positions assigned by VFC. Our Senior Senatorial Legislative Liaison (Thomas Hall) has been active in interfacing with Senator Mark Warner's functions and staff. Additionally, one of our two House Liaisons (Henry Stafford) has been very involved with the staff of Cong. Forbes (see above). Our third liaison position will be filled when our chapters return to traditional meetings in September.

Several Churchland Chapter Board Members will change beginning this Fall.

- Treasurer: Incumbent, James Jones, will begin to shed duties since he plans to travel to Florida for the winter season each year. His replacement is on board and will be 'learning' and transitioning the duties beginning in September.
- Alzheimer's Chair: Incumbent, Bettie Jones, will be joining her husband during their winter respites to Florida. Barbara Whittington has agreed to take over the Alzheimer's Chair position within the chapter when Bettie 'steps down.'

## **GOALS**

- Area IV chapter members hope to meet with Congressman Randy Forbes (as outlined, above) to seek his support of NARFE and America's Heartbeat initiatives, goals and objectives. We are attempting to have an August meeting.

We continue to 'strongly support and advertise' the NARFE, VFC and America's Heartbeat programs to educate our membership; and urge – strongly urge – the membership to call, write, email or text our congressional members and the Presidential office with messages focusing on NARFE and the civilian work force. We encourage the use of the 'tool kit' and provide guidance for those who wish to prepare their own messages, in keeping with NARFE/VFC guidelines. Particular attention has been focused throughout Area IV for National "Call In" day to Congress and the White House.


