FEDERATION PRESIDENT'S MESSAGE



As I begin my first message for 2011, I am very excited to say that things are moving very quickly in the VFC. As most of you are aware, an important resource available to the VFC and to NARFE as a whole is the Active Federal Employee (AFE). In recent months there have been two remarkable events that will bring more AFEs into the rolls as NARFE members.

FIRST – I am pleased to announce that through the efforts of Area II Vice President Betty Warren, NARFE National Headquarters has formally chartered two new Chapters in the VFC of are mostly AFEs. Chapter 2361 (Monticello) is located in the U.S. Federal Building in Norfolk. Chapter 2362 (Joint Expeditionary Base) is located in the Fort Story and adjacent areas of Virginia Beach. With these new charters, the number of VFC Chapters increases from 57 to 59.

SECOND – On February 7th, I received a telephone call from NARFE National President Joe Beaudoin. Our conversation revolved around the fact that increasing the involvement of AFEs and recent retirees, at both the Chapter and Federation levels, is critical to the efforts of our organization. It is common knowledge that many of these AFEs do not want to belong to a specific Chapter. Many of the AFEs are Generation "Y" and grew up with technology and rely on it to perform their jobs better. Armed with BlackBerrys, laptops, cellphones and other gadgets, Generation "Y" is plugged-in 24 hours a day, 7 days a week. This generation prefers to communicate through e-mail and text messaging rather than face-to-face contact and prefers webinars (web seminars) and online technology to traditional lecture-based presentations. Additionally, Generation "Y" may benefit greatly from mentors who can help guide and develop their young careers. In an effort to meet the needs of these AFEs as well as being the mentor to show them the benefits of NARFE, Chapter 2363 (Virginia E-Chapter) has been chartered thereby increasing the number of VFC Chapters from 59 to 60.

Additionally, I would like to welcome Gaston Gianni to the VFC Executive Board as the Public Relations Chair. Gaston retired from federal service at the end of 2004 after 40 plus years. His first 32 years were with the Government Accountability Office (GAO). Additionally, he served as the first Inspector General (IG) at the Federal Deposit Insurance Corporation (FDIC) for 8 years prior to his retirement. He joined NARFE in July 2003 and served as Woodbridge Chapter 1270 Vice President in 2008 and as Chapter President 2009-10. In addition to serving as the VFC Public Relations Chair, he is currently assisting the VFC Executive Board with the development of a VFC Strategic Plan and also representing Region X on the NARFE HQ National By-Laws Review Committee.

As we begin 2011, I am pleased to report that there are many things ongoing within the VFC through the hard work of your Executive Committee, Area Vice Presidents and the Program Committee Chairs. One way to keep up with the direction that the VFC is moving is to visit the VFC Website, www.vanarfe.org, which, through the tremendous effort of VFC Webmaster Stan Palen, has been updated with much information for our members to keep abreast of information and activities within the federation, including the six program areas: Alzheimer's, Membership, National Legislation, Public Relations, State Legislation and Service. I encourage everyone to visit the website and give us your comments on how we can improve upon the messages provided.

Another way to learn more about the VFC and NARFE as a whole is to attend the 57th Annual VFC Convention. It will be held April 25 - 28, 2011 at the Holiday Inn - Koger Conference Center; Richmond. For additional information concerning the event please refer to the "[2011 VFC Convention Documents](#)" link on the VFC web site, www.vanarfe.org. The Convention hosts are the seven chapters in Area VIII. The Convention Coordinator is VFC 1st Vice President, Luther L. Santiful and the Convention Chairperson is Area VIII Vice President Leslie Ravenell. I hope your chapter will be represented at the convention and take part in selecting the leadership for our organization. Three members of the Executive Committee are the incumbent President, 1st Vice President and 2nd Vice President, and if elected, will be term limited in their current positions. Delegates will be voting for new persons to serve as Secretary and Treasurer. Please do all you can to be sure your

chapter is represented by one of more delegates. If your chapter is unable to have your own delegate, please to select someone from another chapter who can represent your chapter by proxy. You can instruct the proxy to vote as you wish on all known issues prior to the convention.

The process of developing a VFC Strategic Plan to help us set and achieve our goals for future years is moving forward. Pierce Johnson, Area IX Vice President, and Gaston Gianni, Public Relations Chair, are spearheading the development of the plan. To date contributions to the development have been made by 7 of 10 Area Vice Presidents and several Committee Chairs. We have inventoried the input under the VFC organizational structure as well as showing the items in the following 8 major categories: (1) Administration/ Operations; (2) Communications; (3) Training; (4) Information Technology; (5) Membership; (6) Service; (7) Legislation; and (8) Public Relations. The next step is for the VFC Executive Committee, Area Vice Presidents and Committee Chairs to individually review the material and to add their input for their respective area of responsibility as well overall VFC. All of the information will be consolidated for my review and use in leading the VFC Board towards the final decision of which important goals should be placed in the Strategic Plan. This should occur either before or right after the VFC Convention in April. Keep in mind that in Virginia, there are 108,000 annuitants, 31,000 survivor annuitants, 144,000 active federal employees and 15,000 postal employees. Currently, there are about 20,000 members in the VFC. The overall goal of the Strategic Plan will be to attract more members as well as retaining our current members. Our strategic plan will have a Purpose, Mission, and Vision Sections before describing our strategic goals.

1st VICE PRESIDENT'S MESSAGE



The snow comes and goes, the groundhog has done his thing and NARFE work continues. Since my last note, I have visited five chapters in various parts of the state. All are working hard to maintain their officer corps and so far have been successful in filling offices for another year. It was heartwarming as I installed officers to find so many veteran chapter officials who were being recycled. My advice, as always, is to assign new members whatever duties they will accept at their very first meeting or soon thereafter.

I am happy to report that we are much closer to our goal of each chapter recruiting an average of at least one member per month. Specifically, in December, 17 chapters recruited 38 new members — up from 35 the previous month and up from 20 recruits per month six months ago. I believe that by convention time, we can make the goal. The Area Vice Presidents are paying the appropriate amount of attention to this effort by assisting chapters as necessary.

Bulletin # 2, discussing details of the upcoming 57th Annual VFC Convention during April 25-28, 2011 in Richmond, was mailed to all chapter presidents on January 30. For the benefit of all members, bulletins 1 and 2 are posted on the VANARFE website, www.vanarfe.org. Registrations and ad activity are slowly picking up and hopefully will finish with a flurry as we near the actual convention date. In the meantime, we are asking all officers and members to support and participate in the convention in some way. Each chapter has been asked to designate a point-of-contact to handle activity leading up to the convention. The convention committee, comprising the seven chapters in Area VIII, is hard at work planning some great activities, work and fun, which should be beneficial and pleasing to attendees.

February 20th, the nomination deadline for the annual R. David Smith Award, is fast approaching. The award is a great opportunity for the VFC to recognize a member for outstanding service to NARFE during the year 2010. Any member may nominate any other VFC member providing the nominee meets the award criteria listed on the VANARFE website.

We are looking at the feasibility of re-organizing some chapters to make them more accessible to members. For example, one chapter covers such a large geographical area that monthly meetings are often moved around to enable more members to attend. Another situation has two relative small chapters in close proximity to each other that may be better with combined memberships. These assessments are on-going with an eye toward greater effectiveness. **REMEMBER - - Promote NARFE - - Recruit a member!**

2ND VICE PRESIDENT'S MESSAGE



As I stated in my report in the November 2010 issue of the VFC Notes, the two primary responsibilities of the VFC 2nd Vice President are to coordinate the activities of the VFC chairpersons (i.e., National Legislation, State Legislation, Membership, Service, Alzheimer's, and Public Relations) and to organize the training of the Chapter officers and chairpersons.

Jim Brewer, the VFC Federal Legislation Chairperson, has been quite active in organizing and recruiting Congressional District Liaisons (CDL's) and Senate Legislative Liaisons (SLL's). These CDL's and SLL's are responsible for leading the effort to contact the federal Congressmen for Virginia and ensuring that the Congressmen are kept apprised of the NARFE issues. Jim is trying to make sure that the CDL's and SLL's are knowledgeable and aggressive. Many of them will be attending the NARFE Legislative Training Conference in March 2011. However, this work has taken a toll on Jim, and he has indicated

that he will have to step down no later than the 2011 VFC Convention. The VFC is currently trying to recruit someone to continue organizational development that Jim began.

Bill Schmidt, the VFC State Legislation Chairperson, continues to lead in the effort to identify and present issues pertinent to NARFE members at the Virginia Commonwealth level. Those of you that have supplied your e-mail addresses to the NARFE National office have recently been receiving weekly reports of Commonwealth legislative actions from Bill on the GEMS system. These reports are also posted on the VFC website and will continue to be sent out through the end of this 45-day General Assembly session. However, Bill's days as the VFC State Legislative Chairperson are numbered, as he will be nominated for election as the VFC Secretary at the 2011 VFC Convention; therefore, the VFC is trying to recruit someone to continue this work should Bill be elected.

Relative to State Legislation, the VFC State PAC (Political Action) Fund is in need of additional money. There is currently only about \$4,000 in this fund and more is needed. The VFC Board has authorized me to modify the current procedures to allow receipt of contributions by credit card as well as by check or cash. I am working on this change and you should see a new VFC State PAC contribution form soon. Also, the person who accepts and keeps the required records of member contributions will be changing from J. Carroll Graham to James Bradley. Additional information and instructions will be provided soon.

Connie and John Bails, the VFC Co-Service Officers, have been quite busy attending and making presentations at both Chapter and Area meetings. They have been providing information on what service is provided by NARFE and why it is important to be a NARFE member. At the Chapter level, they are probably the most recognizable of the VFC Chairpersons.

Dennis Martin, the VFC Membership Chairperson, will be reporting on the status of NARFE membership in the Virginia Federation. The NARFE membership in Virginia is continuing to decline, but at a low rate – 208 members or a 1.1% decline in the last 12 months. However, the effect of the impending NARFE National dues increase is still unknown. Dennis will be participating in a VFC Area 9 and 10 Area meeting in March 2011 at which NARFE membership will be the main topic. Dennis is also maintaining a list of members who recruit new NARFE members during the current VFC membership contest.

Donna Shackelford, the VFC Alzheimer's Chair, was appointed at the beginning of the last quarter of 2010, and has already had a dramatic affect on the collection of Alzheimer's Research contributions. The Virginia Federation goal for 2010 was \$70,000, and I didn't expect that we would meet that goal. However, at the last count \$69,780.79 had been collected by the end of December 2010. Not including the one-time large contribution received from the will of a McLean Chapter member in February 2009, the 2010 contribution exceeds each of the previous Virginia Federation's annual Alzheimer's Research contributions, which included \$66,243.24 in 2009 and \$66,333.86 in 2008.

I would like to welcome Gaston Gianni, the new VFC Public Relations Chairperson. Gaston was appointed at the beginning of January 2011 to take over from Carolyn Wilson. And as you will note in Gaston's report later in these VFC Notes, he is jumping in with both feet and already planning what needs to be done.

All of these Chairpersons, as well as myself, are committed and available to help you in any way that we can. Just let us know what you need from us. As I said before, I am a strong advocate of the importance of NARFE Chapters.

ALZHEIMERS



What an exciting Quarter we've had in the Alzheimer's program. Nationally, through the end of December, we are approximately \$32,000 short of our goal of \$9 million contributions from NARFE to Alzheimer's Research. We will accomplish that very quickly. So far in the fiscal year, VFC has donated over \$22,000 through November 30 for Research, and we are leading Region X by more than double the next federation. All VFC members have worked so hard and continue to do so. It makes it a pleasure to be the Chair of such an ambitious group.

On January 4, 2011, the National Alzheimer's Project Act (NAPA) was signed into law by the President of the United States after having been passed unanimously in both the Senate and House of Representatives. This will create a coordinated national plan to address and overcome the rapidly escalating crisis of Alzheimer's Disease and ensure coordination and evaluation of all national efforts in research, clinical care, institutional, and home/community based programs. Over the last several years, the Alzheimer's Association has been the leading voice in urging Congress and the White House to pass the National Alzheimer's Project Act (NAPA).

As your Chair, I have spoken to members of Winchester Chapter 180, Arlington Chapter 7, and McLean Chapter 489 and provided handouts as appropriate. I have more lined up in the next months, and look forward to assisting any Chapter. I'm also attempting to facilitate the Louisa and Charlottesville Chapters with the Alzheimer's Association to promote the Walk to End Alzheimer's in Charlottesville this fall.

The Convention is right around the corner, and I can tell you we have a great Alzheimer's program to present. We will have a couple guest speakers to bring us up to date on new developments and latest research. I want to conduct a good brainstorming session for a few minutes where everyone in attendance can exchange ideas about fundraising for Alzheimer's Research. Some of the successes for one chapter might be equally successful for others. The more money we can raise, the closer we can come to having Alzheimer's survivors!

Remember to plan and to participate in the Silent Auction at the VFC Convention. This could be another tax deduction for the difference between what the cost of the item is and the price it yields. We'll have some forms available so you can take advantage of that. Of course, Chapters as well as individuals may provide items, services, gift cards, etc. Bring them to the Alzheimer's table as soon as you get there. Each contribution should be worth at least \$25, and anything more is wonderful.

I'm hoping to have a new activity for Alzheimer's also, so check us out. Anyone who would like to volunteer to help me with all of these endeavors at the Convention, please contact me.

MEMBERSHIP

The membership contest, started in August, is off to a good start with 145 new members recruited by VFC members in the first five months of the contest. In all of 2010 the number of new members recruited by VFC members totals 290, or 16.2% of the total of new VFC members recruited for the year. I find these numbers encouraging and hopefully the results of the membership contest will show even better results in the future. Unfortunately, the VFC membership for 2010, unlike last year's increase was down 266, or 1.1%. Transfers, in and out, continue at a slower pace than last year undoubtedly reflecting the poor economy and the downturn in housing prices.

Another disturbing fact is that second renewal notices were ahead of last year. However, through the good work of the chapter officers, non-renewals were behind last year. Unfortunately reinstatements were less than last year and it's apparent that more effort needs to be done in the retention of members.

The dues withholding continues to increase with an additional 6% of members signing up. Now 11.6% of VFC members are having their dues withheld.

Our legislative director and legislative specialists assigned to our Washington headquarters are constantly researching bills and laws that may affect federal employees. In the VA Federation, National Legislation has become so important that the VFC Board of Directors has added a second line of Congressional District Liaisons and Senatorial Legislative Liaisons to aid in building an even stronger defense and better offense against bad bills and laws affecting Federal employees. In the Virginia Federation, Congressional Liaisons support every Congressional district across the state. They are asked to volunteer a tremendous amount

of time in support of not only NARFE members, but other Federal active and retired employees. In many instances, they perform their responsibilities and duties with little or no thanks. Congressional District Liaisons (CDL's) and Senatorial Legislative Liaisons (SLL's) are the lifeline between chapters and their respective Congressmen. Liaisons are tasked with communicating with chapter members, assisting and leading the way in some instances. Our legislative group of Congressional District and Chapter Representatives meet periodically and organize a discussion of our NARFE issues with their respective district Congressman. They believe in planning the event/meeting and then working on the plan. Please welcome your liaisons and help them perform their duties defined in the NARFE organization manual. NARFE-PAC Contribution goals to support the 112th Congress have been provided to all VFC Legislative Liaisons, Area Vice Presidents and board members to distribute to all Chapters. Goals have been broken down by minimum goals of each Chapter, VFC area and the overall goal of \$50,000., which is a reduced goal from the previous 111th Congress goal due to the expected economy downturn of the next couple years. Of course, some Chapters will exceed their goals and others will struggle, but NARFE-PAC appreciates any and all contributions from NARFE members. Members contributing \$20.00 or more will receive a NARFE-PAC pin which can be proudly displayed on their clothing. Accordingly, as of the beginning of the 112th Congress, NARFE-PAC has not originated any funds disbursements to support Congressmen or their special Political events. If you haven't received your Chapter's goal, as determined by the 2010 VFC Convention legislative committee, please contact your Congressional District Liaison. In addition, it's the CDL's responsibility to contact all Chapters, with a significant quantity of members in the Congressional District, to determine NARFE-PAC support or denial of support and then report to the VFC NARFE-PAC coordinator. The NARFE-PAC coordinator will then support or request additional information, look up the voting record and determine accessibility to NARFE members and forward to the next higher echelon in the Organization.

The National Legislative Conference is scheduled March 5-8 and the last day is established to support visits by members to their respective Congressmen or Senators on the hill. Many Congressional District Liaisons (CDL), Senatorial Legislative Liaisons (SLL) and Area Vice Presidents (AVP) are planning to attend the Educational Conference. In addition, many are planning to visit their Congressmen on the "hill". CDL and SLL's planning to attend, are requesting a short meeting of all VFC member attendees to discuss plans to be more effective and efficient with the time allowed to meet with their Representatives and Senators. Please contact your respective Congressional District Liaison to discuss "networking" suggestions. Together, we can make a difference.

SERVICE OFFICERS

Should You Get A New Military Id Card At Age 65 Or Not? - - - Technically, it's not required but it may save you some grief down the line.



ID cards for retired military members have an "indefinite" expiration date on the front of the card. On the back of the card is an expiration date for medical benefits that expires the month prior to you turning age 65. While your entitlement and access to medical benefits do not end after the expiration date, it could cause problems if you don't update your card.

We recently received an email from a member who told us of his trip to the base pharmacy. He still used his original retired ID card with an expired medical date on the back. His card was confiscated by the pharmacy. Turns out, the base hospital implemented a local policy to confiscate cards in an effort to get cards updated for those over 65 years old.

In this fast paced, ever changing world, military ID cards have undergone several updates over the years, photos get old, and some service providers won't understand the date on the back doesn't render the card expired. People aren't ID card experts. An expired date means one thing to most; game over. Save yourself the potential grief and get a new card.

New Way of Stealing Credit Card Information - - Thieves now have another way of stealing your credit card information without coming in contact with your wallet. With new technology, they can now simply walk past you or sit next to you on the Metro and retrieve your card information.

Most Cardholders aren't liable for fraudulent use of their credit cards, but secure sleeves that block these transmissions have been developed and marketed. During this New Year we want to make you aware of this emerging technology.

We have heard from members who were concerned about a decrease in their federal tax withholding (they wanted to make sure the reduction was not going to result in under withholding) and this year members are upset about an increase in tax withholding. Actually, it is not an increase but a return to pre-2010 withholding tables. Below is an explanation and rationale for the withholding change thanks to David Snell, Director of Retirement Services, NARFE Headquarters.

The Making Work Pay credit expired December 31, 2010, which could mean higher federal tax withholding amounts in monthly annuities for federal retirees. The IRS issued a notice in December saying withholding tables for 2011 would no longer be adjusted for the Making Work Pay tax credit and there is no longer an optional additional withholding adjustment for pensions.

The Making Work Pay credit was created with the passage of the American Recovery and Reinvestment Act, PL 111-5 signed into law February 17, 2009. The credit equaled 6.2% of a taxpayer's earned income up to a total credit of \$400 for individuals and \$800 for Joint filers. Last year the IRS asked employers to use the new withholding tables to adjust workers' take-home pay to account for the new credit as soon as possible and they emphasized that employees did not have to fill out a new W-4 withholding form; that the adjustments would be automatically made based on the 2010 withholding tables. Those withholding tables also affected federal retirement payments. With the expiration of the temporary credit, IRS tax withholding tables have changed for 2011 and many retirees may see an increase in the amount of federal tax being withheld from their monthly annuity payments as a result.

It is important to keep in mind that like all employers, OPM uses tax withholding tables that are provided by the IRS and questions about changes to those tables must be referred to the IRS, not OPM.

As a reminder, federal annuitants receiving payments from OPM can change their tax withholding amounts for both federal and state taxes, by contacting OPM. Retirees can call OPM at 1-888-767-6738 or make changes on-line at www.opm.gov/retire. We would also suggest retirees use the OPM on-line tax withholding calculator at the same site before making a change to their monthly tax withholding.

STATE LEGISLATION



We have distributed over 1500 copies of the 2011 State Legislation plan to members of the General Assembly and to our members. Several of our members have personally discussed the plan with members of the House and Senate. Others are preparing to do so during the session. Of our five issues several applicable bills have been introduced. The only bill on expanding the availability of voter lists was defeated in committee in December after being continued from last session. There are four bills to create language in the Virginia Constitution to protect an individual's property rights in cases of Eminent Domain takings by the state. Additional efforts to address the transportation and Aging issues in our program will depend on the budget amendment that is passed.

The annual State Legislation Committee meeting will be held at the Holiday Inn Koger Center on June 16 from 10:00 AM to 2:00 PM. At that meeting the State Legislation Committee of the VFC which is composed of the SL Chair, two SL representatives, the 10 AVPs and their Area SL coordinators along with the VFC President, and his two Vice Presidents, will prepare a draft plan for the 2012 Legislative Session and select which candidates we would like to support. Selecting candidates to support this election cycle will be more difficult as the General Assembly has moved the date of the primaries from the second Tuesday in June to August 23rd to accommodate the redistricting process. We will be making our best guess at the July Board meeting as to which candidates will be running for election. The final decision on funding of candidates is made by the 5 members of the VFC Executive Committee so they will be able to decide after the primary season.

Every Chapter is encouraged to consider issues that the VFC should include in our legislative program for 2012 and to identify suitable candidates for financial support in the Fall 2011 election. The State Legislation section of the VANARFE web site (www.vanarfe.org) has instructions and coupons for suggesting ideas for legislation and for suggesting suitable candidates for support. Suggestions should be forwarded to either the State Legislation Committee Chair or to your local Area Vice President so they can present the ideas on June 16th.

We need to make a significant effort to increase the funds in the VFC PAC as there will be 140 seats open for candidate support this fall. Our current balance is about \$4,000 which is insufficient to provide reasonable donations to many candidates. Each Chapter is encouraged to make an effort to find donors for the VFC Political Fund. Coupons for making donations are on the State Legislation section of the VANARFE web site.



In addition to the Chapter 1270 Fashion Show, chapters in Area X continue to find creative ways to raise money for Alzheimer's. One chapter raffled a cake. One chapter had a large raffle basket their holiday party. After the holiday party an anonymous donor sent in a check for \$850 for Alzheimer's. Another chapter had a raffle and sold poinsettia plants. One chapter had a silent auction and several chapters have a 50/50 drawing each month. One chapter sells Entertainment books.

I participated in the health fair sponsored by 11th District Congressman Gerry Connolly at the Fairfax County Government Center on December 4, with members of Chapters 737, 1116, 1241 in Area X and Chapter 1270 in Woodbridge in Area IX. Several NARFE members attended. Congressman Connolly spent quite a bit of time with the NARFE members and posed for pictures.

Six of the seven chapters in Area X ended the year with holiday parties. I attended parties with Chapters 7, 1116, 1131 and 1241. At Chapter 1241, National President Joe Beaudoin installed the officers. At Chapter 1116, National Vice President Paul Carew installed the officers. I installed officers at Chapters 7 and 1131.

The next caucus meeting on March 3 for Area IX and X will be devoted to membership. VFC Membership Chair Dennis Martin and the two area membership coordinators will attend. All officers and membership chairs were invited.

After a very successful Senior Expo in October at which they recruited 16 new members, Chapter 7 is having a recruitment contest with prizes of \$100, \$75, or \$50 for the top three new-member recruiters this year. The awards will be made in December for the largest number of active or retired members recruited from January through September. In order to help in their recruitment effort, and for the convenience of working members, their regular March meeting will be on THURSDAY March 10 at 7:30 p.m. at Culpepper Garden Room 3 with refreshments at 7.

Chapters were encouraged to sign up for the Legislative Training at Crystal City and the VFC Convention in Richmond.

As of the end of December, membership in Area X declined by less than 1%. Chapter 7 gained 23 new members in 2010 and gained 16 new members after the Senior Expo held in October. Area X showed more than a 10% increase in dues withholding for the 2010.

REGION X VICE PRESIDENT'S REPORT

I doubt anyone will disagree that these are difficult times. Unemployment is high, the deficit is in the trillions, and congress is in the process of balancing the budget – our concern has to be that it is not on the backs alone of the active and retired federal employees or their spouses. Many retirees and active employees as well think our annuity, health, and other benefits are set in stone, but they are wrong. As the old saying goes, what congress gives, congress can take away. We must constantly be vigilant, doing what we can to protect those benefits.

Last September, at the convention in Grand Rapids, the membership recognized the need for a dues increase and did approve one that will take effect with membership renewals starting in March 2011. Now, with the economy in such dire condition and an aggressive group of politicians doing what they can to balance the economy, NARFE is going to need to take bold steps to do what it can to protect our earned benefits.

In my opinion, it is time we took extraordinary measures to counter the ongoing and increasingly bad publicity we are getting from congress and the public as well as in the newspapers. While we have not completely recovered financially, with our recent dues increase, I believe it is time that we invest in actions that will help us retain those earned benefits and counter the bad publicity we are receiving. If we do not use funds that are available to do what we can to improve our situation, we might see the time where we have funds in the bank but have lost some of our benefits. I just don't think we can allow that to happen.

The NEB has approved a contract with M&R/Strategic Services. According to Dan Adcock and Joe Beaudoin, M&R has worked with many similar nonprofit organizations, and with their expertise and assistance, we are in the process of launching a PR effort in targeted states to refute false statements and mobilize our members. In addition, the NEB has approved an additional \$250 thousand for advertising in selected markets, both inside and outside the DC area.

The idea is to advertise in areas with large numbers of both active and retired federal employees, as well as in areas represented by influential politicians who have the ability to help ... or hurt us. We want to do what we can to influence them to help. As Joe Beaudoin has said "It will not be cheap, however, if we continue to do business as usual, we are (in my opinion) doomed."

Two other activities in process at NARFE are the NIAC and the Membership committee. Both are national programs using field members. The NIAC (National IT Advisory Committee) is looking at all electronic activities from reports to banking, and it has five field members who will finalize their recommendations this coming July at the Federation Presidents meeting. The other is really two committees, both on Membership. One committee will be working on recruitment and the other on retention. Both have five members from the field. It too will report at the July meeting.

The bottom line is, that NARFE is actively pursuing activities that we feel will protect our earned benefits. Please feel free to let me know of your concerns and of any questions you may have.
